## REGISTER OF MEMBERS' INTERESTS

### NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, ELIZABETH NEALE a Member of the Elmstone Hardwicke Parish Council ("the Parish Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Parish Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

### PART A

#### DISCLOSABLE PECUNIARY INTERESTS
